Quakers have never practised water baptism or christening.

On 4 April 1763, Thomas Archer was Received on Request by Burlington Monthly Meeting. On 2 May 1763, Burlington Monthly Meeting granted Thomas Archer a certificate to marry Mary Small at Evesham Monthly Meeting. On 12 May 1763, Thomas, son of Amos Archer of Gloucester, married Mary Small at Evesham Meeting House.

On 27 July 1764, a son was born to Thomas Archer of Burlington. On 1 February 1766, a daughter was born to Thomas Archer of Burlington. On 12 July 1767, Burlington Monthly Meeting granted Thomas a certificate to join Evesham Monthly Meeting.

On 8 December 1768, Thomas, wife Mary & children Samuel, Lovet, Hepsabah & Beulah were received by Evesham Monthly Meeting, on certificate from Burlington MM.

In 1793, Thomas Archer was listed as a member of the Greenwich Township, Gloucester County, New Jersey, Militia.

General Notes (Wife)

Quakers have never practiced water baptism or christening.

On 9 April 1761, Mary Small was "Received" as a member on request, by Evesham Monthly Meeting. On 6 September 1764, Mary Archer was granted a certificat by Evesham MM, to join the Burlington MM. On 5 November 1764, Mary Archer (formerly Small) was received in the Burlington MM on a certificate from Evesham MM, dated 6 September 1764.

The 21 August 1768, the LW&T of John Small mentioned his daughter Mary as the wife of Thomas Archer.

Mary Small Archer, her parents and siblings, have been Baptized, Endowed, and Sealed in the LDS Church, at Manti, Utah, 1937-1963. The family proxy representative was Verna Johnson (no known relation to the compiler) Black.

Whereas Thomas Archer, son of Amos Archer of Gloucester County in ye Province of New Jersey, and Mary Small daughter of John Small of ye Township of Evesham and County of Burlington and Province of New Jersey, having declared their intentions of marriage with each other before several monthly meetings of ye people called Quakers at Evesham aforesaid and having ye consent of parents and relations concerned their proposals of marriage was allowed of by ye said meeting.

Now these may certify all whom it may concern that for the full accomp-lishing their said intentions this 12th day of ye 5th month 1763, they the said Thomas Archer and Mary Small appeared in a public meeting of ye said people at their meeting house in Evesham aforesaid and the said Thomas Archer taking ye said Mary Small by ye hand did in a solmn manner openly declare that he took her the said Mary small to be his wife, promising through Divine assistance to be unto her a faithful and loving husband until death shall separete them, and then and there the said Mary Small did also in like manner openly declare that she took him the said Thomas Archer to be her husband promising through Divine assistance to be unto him a loving and faithful wife until death should separate them, and moreover they ye said Thomas Archer and Mary Small, she according to ye customs of marriage assuming the name of her husband, as a further confirm- ation thereof did then and these present set their hands, and we whose names are hereunto subscribed present at ye solemnization of ye said marriage and subscription have as witnesses thereunto subscribe our hands ye day and year above written.

General Notes for Child Mary M ARCHER-[111]

Quakers of record were required to join the meeting nearest their place of residence and were given letters of transfer if they moved or if a new meeting was established nearer their home than the one to which they currently belonged. These letters of transfer were routinely recorded in the minutes of the monthly meeting for business of the two congregations involved.

Common items on the agenda of monthly meetings for business were marriage intents and oversight, membership transfers, all financial matters, requests for membership and the consideration of testifications brought against members believed to be violating Friend's "testimonies". "Testification" were always followed up in the meeting minutes by either an appeal from the accused, a letter of repentance or the "disownment" of an unrepentant member. It was not uncommon for "testifications to be brought against members for such infractions as "neglecting meetings for worship", "drinking spirituous liquor more than is necessary", "having a child sooner after marriage than is respectable" or "striking another man in anger".

Quakers are noted for maintaining and preserving accurate accounts of their monthly meetings for business. Ancient Quaker monthly meeting mInutes are preserved in either the archives at Swarthmore College or

Haverford College and are often complete for time spans exceeding three centuries.

Only members of record were permitted to participate in Quaker monthly meetings for business. Therefore, the names of non-members will rarely if ever appear in meeting minutes. In contrast to non-member attenders the names of every member of record in the Religious Society of Friends will always appear at some point in time in the meeting minutes for some reason. At the very least, members names appear for reasons such as a transfer of membership, a censure for "non-attendence" or perhaps disownment for "marrying out".

Quaker marriage certificates are a unique source of genealogical information because everyone who attended the ceremony was invited to sign the certificate as a witness. There was an established order in how the near relatives of the newly married couple signed this document. Copies of these certificates, which sometimes contained forty or more signatures, were often entered into the monthly meeting for business minutes. Because so much information is preserved in Quaker records, genealogists are always happy when they determine that the subject of their research was a member of the Religious Society of Friends.

Burlington County was predominantly Quaker in the 1700's. Historically during this time Quakers controlled the wealth and political power. Prior to the Revolution it would have been acceptable and even beneficial to consider yourself a Quaker in Burlington County.

Friends believed that, "there is That of God in every man". To commit violence against another person was tantamount to committing violence against God. Therefore, being "in unity" with Friends meant to them, among other things, practicing absolute non-violence in their daily lives. Quakers believed that it was always wrong to return evil with evil. They believed in speaking "Truth" to "power" and responding to evil with Good. Many people who were sympathetic with the testimonies of Quakerism otherwise, felt that they simply did not have the "spiritual strength" to remain non-violent in every situation in which they could imagine finding themselves, especially if it involved imminent harm to a loved one.

Quakers never practiced water baptism, or any outward form or ritual.

On 6 February 1783, Mary (a minor) was granted a Certificate by the Evesham Monthly Meeting (MM), to join Mt. Holly MM. On 4 December 1783, Mary was received by Mt. Holly MM, on Certificate from Evesham MM.

On 8 December 1785, Mary was granted a Certificate by Mt. Holly MM, to join Haddonfield MM. On 1 September 1786, Mary (a minor) was received by Haddonfield MM, on Certificate from Evesham MM.

On 10 August 1795, the Haddonfield MM informed that Mary Hall (late Archer) "hath been guilty of unchaste conduct by going out in marriage." On 14 September 1795, Mary was "Disowned" by the Haddonfield MM because she "married out of unity".

On 3 October 1813, Mary Hall wrote the following to the Haddonfield MM, "Having in my youth deviated as to be guilty of unchaste conduct befor marriage and likewise to accomplish my marriage contrary to the good order used among friends which has brought sorrow to my own mind and trouble to my friends. I do hereby sincerely condem my former misconduct and earnstly desire that frineds may it by and receive me into membership again with them. From your friend Mary Hall". "The Haddonfield MM "unites in receiving" Mary.

On 8 November 1813, Mary Hall was granted a certificate by Haddonfield MM, to join the Miami (Ohio) MM. On 26 January 1814, Mary Hall was received into the Miami MM (Hicksite Branch), Waynesville, Warren County, Ohio on a Certificate from Haddonfield MM.

On 26 January 1825, Mary Hall was disowned by the Miami MM for "neglecting the attendance of our Meetings" and "joined another society".

The 1840 Census included Mary, living with her son Charles Hall in Wayne Township, Warren County, Ohio (1 female, age 70-79).

On 11 September 1850, Mary was living as a widow, with her son Charles Hall, in Johnson Township, Champaign County, Ohio.

Mary may be buried in the Everett or Wells Cemetery, East of Lena, Ohio.
