# Feb. 6, 1868 Thursday

**p. 3** Philip Wilson, a prominent citizen of Thompson, died last Monday of consumption. A son and daughter have died of the same disease within a year.

Assault — Monday afternoon, Daniel Adams assaulted C. Lace, of LeRoy, with a slung shot on the sidewalk near S. T. Ladd's store striking him several times and cutting three holes in the top of his head, and bruising the side of his left eye. Officers arrested both men. Mr. O. Loomis, of LeRoy, went bail for Adams after C. Lace made his complaint.

Mrs. Sharp, an old resident of Willoughby, died on Jan. 9<sup>th</sup>.

The Late Silas Pepoon – With his parents, Capt. Joseph Pepoon and Mrs. Eunice Pepoon, his three brothers and one sister, he came to this place from Hebron, Conn., in 1804. They traveled the whole distance in wagons. Mr. Pepoon's 12<sup>th</sup> birthday occurring on the road. Silas Pepoon hid many slaves and helped them to get to Fairport to take a ship across the lake to Canada and freedom. In the spring of 1850, Mr. Pepoon moved with his family to Warren, Jo Davies Co., Ill. His five sons were all in the union army and the youngest, Oren, gave his life for his country. Silas died at age 75 yrs; the

first death out of four brothers and one sister—the youngest of who is 65 yrs. old. The family is of French Huguenot descent and came to this country from the Island of Corsica.

The horse, carriage, and children went down a bank 30' and landed on solid rock. The son badly injured, the two daughters less seriously.

# Feb. 20, 1868 Thursday

**p. 3** Last Thursday, the Congregational Church of Thompson took fire and burned down. It was built only about six or seven years ago.

Last fall, Jesse A. Mansfield sold his house and lot on Mentor Ave. to Harvey Cram and took in exchange a farm in Michigan near Hillsdale.

Died Madison Jan 26, Joseph Cady, age 80 yrs. He was one of the early pioneers of Ohio. He was born in Norfolk, Conn., in 1787; he came to Austinburg in 1811, where he lived until 1812 when he volunteered and went into the army as drum major; on his return he purchased land in Madison (at that time there was not a house in the place). He felled the first tree that was cut in Centerville. He was a resident of Madison 54 years. He leaves one aged wife to whom he had been married 51 years, and four children—three sons and a daughter.

## Feb. 28, 1868 Thursday

**p. 3** Among indictments from the Grand Jury there is one against Dr. John R. Rutley, for bigamy. The amorous doctor, it seems, had one wife, and while here, married another; he is said to now be in Baltimore.

General Grant is the choice of the Republicans of Lake Co. for President.

Died in Thompson on the 3<sup>rd</sup> instant of consumption, Philip Wilson, age 57 yrs. Also, on May 26, last year; his son Marshall, age 18; and last Nov. 15, his daughter Carrie (Mrs. Bovier)—all of the same disease—consumption. Philip Wilson was born in the town of Sterling, Windham Co., Conn, in 1811; came to Ohio in

the autumn of 1836 and purchased the farm where he settled and lived until his death. He did much in the way of experimenting and growing various fruits.

Mrs. Webster and sons are fatigued but free of disease. With the very strict precautions adopted by the neighbors, there seems to be no danger that the disease would spread.

#### Weather: Another Severe Storm

The storm of wind and rain of Thursday and Friday last was very severe and delayed the trains from the East. The heavy and long continued rain added to the sudden melting of a large body of snow on the ground, occasioned floods such as we have never before witnessed in this part of the county.

#### **Justice to a Brave Soldier**

During the war in the winter 1862-63, B. W. Canfield, of Chardon, a Capt. in the 105<sup>th</sup> Vol. Inf. was surprised and captured while out on a foraging expedition near Murfreesboro, and for this was dismissed from the service in disgrace. After several months in prison, he had been exchanged and returned home. His fellow citizens regarded him as a victim of a grievous wrong. Hon. James A. Garfield, House of Representatives, had applied for a revocation of this order by Gen. Rosecrans dismissing Capt. B. W. Canfield, and has heard from the War Dept., March 10, 1868, that the Captain will be allowed to substitute a resignation as of the same date of the dismissal by Gen. Rosecrans.

#### **Days of the Pioneers**

When Geauga Co was organized in 1806 the country seat was at New Market from 1806 – 1810. The County Court consisted of a Presiding Judge and three Associates. The first

Associate Judges in the county were: Aaron Wheeler, John Walworth, and Jesse Phelps-Calvin Pease was the presiding officer. The members of the bar were: Samuel W. Phelps, Painesville; Robert B. Parkman, Parkman; Thos. D. Web and John S. Edwards, Warren; and Homer Hine, Youngstown. At the first Court held in Geauga Co. in March, 1806, Edward Paine Jr. was appointed Clerk and Robert B. Parkman, Prosecuting Attorney. The County Officers were: Sheriff - Charles Parker; Recorder - Jas. Harper; Treasurer - Eliphalet Austin of Austinburg; Commissioners - Dr. Hawley, of Austinburg, Colonel Beard, of Burton; and Nath. Doan, of Cleveland. The Court held its sessions most of the time while at New Market, in Capt. Skinner's barn. At one time a man named Meeker was tried for stealing a bar of iron from Harper's Blacksmith's Shop. He was sentenced to be publically whipped 10 lashes on his bare back. It was the mildest sentence that could be given for this case. The barbarous practice of whipping for minor offences was then tolerated by the laws of Ohio, but it was soon blotted out; and but few know at this time that it ever was a statute in Ohio. In 1806 or 07, Homer Hine, of Youngstown, was authorized by the Legislature to locate a road from the south line of the Reserve to the Lake at the mouth of Grand It passed through Painesville, and crossed the river at New Market Landing. As it was established by the State it was called State Road—and within the corporation Painesville, it is now called State Street. It was the first road opened from the south part of the Reserve to the Lake. H. E. Paine, Monmouth, Illinois, Aug. 7, 1868
