David Evans added the "D" to his name to distinguish himself from the other David Evans men living in his area of Utah (Carbon County). He was killed in the June 1, 1900 mining explosion which many still be the worst mining accident in Utah in terms of the number of lives lost.

**WIFE - Hannah Mouter YOUNG**

Her parents are Andrew Young and Elizabeth Mouter. She traveled to America with her sister Mary in May 1886 on the ship Nevada, arriving in New York on June 1, 1888. They traveled by train arriving in SLC on June 8 1886. The rest of the family had come in 1885.

She married Christmas Davis in 1901 and was widowed a second time in 1912 when he was killed in a mine accident in Castle Gate. I never found any children of this marriage.

She married Joseph H Jewkes on 24 Aug 1924 . His death certificate File #10 heart problem.

She received a check for \$114.00 from the Scofield Fund July 15, 1900.
