

south of Bartow in what was then Hillsborough County but was later made into Polk County. (See sketch on James M. Keen). James and Elizabeth had no more children but she helped raise the younger Keen children. They were members of Mount Enon Primitive Baptist Church and later Bethlehem Primitive Baptist Church where James M. Keen was pastor.

Elizabeth lost her third husband on September 29, 1885. In 1894, she applied for a pension based on the service of her third husband, James M. Keen, in the Florida Seminole wars. She received \$8.00 a month until her death on Dec. 21, 1901. She was buried at Bethlehem Cemetery near the Polk-Hillsborough County line. Elizabeth left a will in Polk County:

"In the name of God, amen. I, Elizabeth Keen of the County of Polk and State of Florida, being of sound mind and reposing memory, and considering the uncertainty of this frail and transitory life, do make, constitute, ordain and decree the following to be my last will and testament bequeathing and disposing of my property in the following manner, to wit:

1st. That after the payment of my just and lawful debts and my funeral expenses by my executor hereinafter mentioned, I desire that the rest and residue of my property be divided as follows:

2nd. To my beloved daughter, Celia Jane Rimer, I give and bequeath the following lands, to wit: the northwest quarter of the southwest quarter of section eighteen, also the north half of the north half of the southwest quarter of the southwest quarter of said section eighteen, all in Township thirty-one south of Range No. twenty-three east, containing forty-nine (49) and 97/100 acres, - together with all and singular the improvements and appurtenances thereunto belonging or in any-wise appertaining.

3rd. To my beloved grand daughter, Mary Ardelia Rimer, I give and bequeath twenty-six and two-thirds of an acre off of the north side of the northeast quarter of the southwest quarter of section eighteen (18) in Township thirty-one (31) south of Range No. twenty-three (23) east.

4th. To my beloved grandson, James Hampton Rimer, I give and bequeath twelve and one-third of an acre (12 1/3) off of the south side of the northeast quarter of the southwest quarter of section eighteen; also fourteen and one-third of an acre (14 1/3) off of the north side of the southeast quarter of the southwest quarter of said section eighteen (18), all in said Township thirty-one (31) south of Range twenty-three (23) east.

5th. To my beloved grand daughter, Hattie L. Lee Rimer, I give and bequeath twenty-six and two-thirds of an acre (26 2/3) off of the south side of the southeast quarter of the southwest quarter of said Section eighteen (18) in Township (31) thirty-one south of Range No. twenty-three (23) east.

6th. To the heirs of the body of my beloved daughter, Eliza Ann Rimer, wife of Alexander Rimer, I give and bequeath the sum of ten dollars (\$10.00) lawful money of the United States.

7th. To my beloved grandson, J. E. Whidden, I give and bequeath the sum of ten dollars (\$10.00) lawful money of the United States.

8th. To the heirs of the body of Marantha Daniels I give and bequeath the sum of ten dollars (\$10.00) lawful money of the
