James and Assilla Keen were living in Tattnall County in the 1830 Census. They were living in Appling County in 1832 where their daughter, Elizabeth, was born. In 1836, they moved to Columbia County, Florida where they were listed in the 1840 Census living between Daniel Gillet and David Walker. Joseph Keen, David Keen (who had moved from Tattnall County to Ware County and then to Columbia County about 1832) and William H. Keen were also living in Columbia County in 1840.

James M. Keen was a private in the Florida Militia for three enlistments during the Florida Seminole Indian Wars. He enrolled on July 10, 1836 at Fort Lancaster, Florida in Capt. Brown's Co. of Mounted Florida Militia & was honorably discharged on Sept. 22, 1836. He served two enlistments in Capt. McClellan's Company,
