- 2. Moses Keen, born June 15, 1859; died Aug. 23, 1936; married in Manatee County on Feb. 9, 1882, Lucy Caldonia Hand, daughter of James and Amanda Hand.
- 3. Samuel Keen, born Mar. 7, 1861; died Dec. 13, 1933; married on Jan. 21, 1886 in Manatee County, Frances Vianna "Frank" Chancey, daughter of Edmund & Temperance (Thomas) Chancey.
- 4. Rachel Keen, born Apr. 21, 1863; died Dec. 19, 1936; married Dec. 21, 1890, H. Perry Grimes.
- 5. Andrew Jackson "Ander" Keen, born 1866; died June 24, 1955; married 1st, on July 15, 1891, Ruth Angeline Chancey, daughter of Edmund & Temperance (Thomas) Chancey; married 2nd, Mary Ann Gill.
- 6. Nick Bud Keen (early census give his name as Nicebud or Nichabud), born Apr. 10, 1870; died 1940; married on Dec. 12, 1892, Georgia Ann Chancey, daughter of Edmund & Temperance (Thomas) Chancey.
- 7. Ann Keen, born Feb. 1, 1873; died Sept. 27, 1915; married on Nov. 3, 1887 in Manatee County, her first cousin, Lewis D. Rutledge, son of John T. & Savilla (Keen) Rutledge.
- 8. Caroline Keen, born 1875; died 1971; married on June 14, 1900, Perry Yuley Chancey, son of Edmund & Margaret (Stephens) Chancey. Perry Y. Chancey was a half-brother to Frances V., Ruth A. and Georgia Ann Chancey who married Caroline Keen's brothers.
- 9. Nancy Jane Keen, born January 1878; died May 1960; married on Aug. 3, 1905, Philip Chancey, son of Perry Yuley & Jemima (Byrd) Chancey.

In 1860, Jacob Keen & family were living near Bronson in Levy County, Florida next door to his brother, Moses Keen & family. Jacob Keen moved to Manatee County prior to Nov. 5, 1866 when his name appeared on a list of jurors which met at the Manatee County courthouse.

In the 1870 Manatee County census, Jacob Keen was living in Township 34 in the Duette area along with Edmund Chancey, Berry Keen,

his mother, Elizabeth Keen age 70, and Herod Keen.

On Dec. 20, 1877, Jacob Keen purchased 80 acres of land for \$.90 per acre from the Internal Improvement Fund. This land was described as the $E_2^{\frac{1}{2}}$ of the SE $\frac{1}{4}$ of Section 22 in Township 33 South, Range 21 East. On Oct. 10, 1881, Jacob Keen purchased an additional 80.02 acres from the Internal Improvement Fund of Florida at 90¢ an acre. This land was the SW $\frac{1}{4}$ of the NE $\frac{1}{4}$ and the SE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 22 in Township 33 South of Range 21 East. On Sept. 21, 1881, Jacob & Elizabeth Keen sold to Moses Keen and Samuel Keen for \$100, 40 acres of land described as the NE $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 22, Township 33 South, Range 21 East. Moses Keen, Samuel Keen and William J. Keen bought land in Township 33 in 1882 from the Internal Improvement Fund.

On April 11, 1888, Jacob Keen applied for a pension based on his service in Capt. Jack Knight's Company during the Seminole Indian Wars. His post office was Rye, Manatee County, Florida and his description was age 61, 5' 10", light complexion, black hair & blue eyes. His signature on the following page is from this pension application.
