Maxwell Whidden was living in the Fort Thompson Settlement near the Caloosahatchee River in 1870, along with Ephraim W. Thompson, Daniel Stewart, John Patrick and Jesse Lee. In the mid-1870's the Whiddens settled in the Joshua Creek area of Manatee County (present day DeSoto County). They were members of Mt. Moriah Baptist Church. Maxcy Whidden was a delegate from his Church to the Second Annual Session of the Manatee Association in November of 1877. He was a member of the committee on Sunday Schools. He was also a delegate in November of 1880 to the Fifth Annual Session when he was selected to serve on the Executive Committee.

Maxwell Whidden died April 27, 1887 at his home in Nocatee, Florida

and was buried in the Joshua Creek Cemetery.

On August 6, 1890, Mrs. Judia A. Whidden applied for a widow's pension based on Maxwell's Civil War service. Wright Carlton and J. M.

Carlton were witnesses to her mark.

E. W. Thompson, aged 60 years, a resident of Fort Ogden gave the following affidavit in support of Mrs. Whidden's pension claim: "I have known Judia A. Whidden for twenty-five years, and have every reason to know the contents of her property which consists of:

one horse \$200.00 one 40 acre tract of land one stock of cattle two hundred head \$1,000.00

The income derived from this property to the best of my knowledge is

\$135.00 a year and the cost of hunting cattle is \$50.00 (leaving) \$85.00."
On March 15, 1893, Judith (Hendry) Whidden married Henry Langford. Willoughby Whidden was appointed guardian of Lorena Whidden. Judith died on September 4, 1899 at Nocatee and was buried in the Joshua Creek Cemetery.
