"He and Demps got into an argument. One accused the other of stealing a pig. Or maybe Lucas thought that Charlie Crews had stolen the pig. It didn't matter now. But they had some words and Crews grabbed his gun and shot Lucas. Lucas fell and Demps went to his horse to leave. Demps had one hand on the saddle and the other hand on his horse's neck, ready to mount, when my uncle John Collier, shouted: 'Look out, Demps, he's going to shoot you.' And Demps turned just in time to catch a load of buckshot in the face. Lucas had raised up to one knee after being shot down. Dempsey Crews fell down and died right there."

Dempsey's will which was dated October 1, 1890 was probated June 18, 1895. It named all of his children living in 1890 and named his brother, Crawford Crews, as their guardian. It named Charles B. Collins and W. C. Crews as executors.

On July 20, 1895, Martha Jane Crews made application for the money which had accrued on her deceased husband's pension certificate from

his last payment on May 4, 1895 up to his death.

Martha J. E. Crews married Benjamin L. Crews on July 8, 1897. In the 1900 DeSoto County census, Francis, age 10, Harvey K., age 13, Dempsey D., age 18, Charles W., age 24 and John B., age 22 with his wife & son were living with Edward Crews, age 28. On October 27, 1903 E. E. Crews was appointed guardian of the remaining minors of D. D. Crews, Jr. Thomas W. Crews received his last pension payment as a minor on October 20, 1909.

Martha J. E. (Lanier) Crews died December 22, 1910 and was buried in the Crewsville cemetery near her husband, Dempsey D. Crews,
