- 9. Adline McClelland, born April 19, 1873
- 10. Victoria McClelland, born c1875.
- 11. George McClelland, born c1879; never married.
- 12. Elias E. McClelland, born December 30, 1882; married Jenny "Sis" Monts De Oca, July 18, 1912. Died 1951 and was buried at Ft. Denaud Cemetery, Hendry County, Fl.
- 13. Susan E. McClelland, born March 26, 1885; married Charlie Pride, December 29, 1909.

During the Civil War, Jesse McClelland enlisted at Fort Meade, Fl. in Captain F. A. Hendry's Company, First Florida Reserves, also known as Munnerlyn's Battalion. He was home on furlough at the end of the war and was discharged in Polk County, Florida according to his pension application. He applied for a pension on November 4, 1907 and was awarded a pension of \$120 per year by the State of Florida on Jan. 8, 1908. Under the Act of 1909 he submitted another application and was awarded a pension of \$120 per year on certificate No. 5762. Signing supporting affidavits stating that they were in the same battalion as Jesse were D. L. Lanier of Crewsville, DeSoto County and A. E. Godwin of Kissimmee River, Polk County, Florida.

In the U. S. census of Polk County, Florida of 1870, Jesse and Susan were living near his father and mother and brothers, William A. and John McClelland and their families. By 1880 he had moved to Manatee County (in present day DeSoto County) and was living in Prct. 11, District 104. His brother, Moses A. McClelland, was also living in Manatee County at this time. He moved back to Polk County prior to 1900 and was living in Prct. 14 at Midland, between Frostproof and Ft. Meade. The census of 1900 shows his neighbors to be Reading Douglas, Leander Underhill, his daughter & her husband, Exaline and William H. Carney, and his son Jesse and wife Caroline. Jesse's occupation was given as a mail carrier.

On July 12, 1902 Jesse made an application for pension based on his Seminole Indian War service. He gave his residence as Midland with post office as Ft. Meade, Florida. He was awarded a pension on certificate No. 50081. He did not apply for bounty land. On October 6, 1905 he made application as administrator of his father's, Silas McClelland, estate in Polk County, Fl. Jesse died Nov. 27, 1912 and was buried in Little Eden Cemetery west of Frostproof, Florida.

After Jesse's death Susan applied on Jan. 4, 1913 for a widow's pension which she received until her death on Nov. 24, 1920. Her son, George C. McClelland was administrator of her estate. She was probably buried in an unmarked grave next to her husband in Little Eden Cemetery.
