- 1. Luna Mizell, born August 26, 1874; died August 4, 1894 from typhoid fever; never married.
- 2. Walter Falon Mizell, born January 12, 1876; died July 16, 1914; married Melda Cline.
- 3. Ellen Knight Mizell, born August 7, 1878; married Harry Crippen.
- 4. Roscoe Conklin Mizell, born February 6, 1880; married Anna Hanson.
- 5. Elizabeth "Lizzie" Mizell, born March 21, 1882; died May 5, 1904 and buried in Joshua Creek Cemetery; married Archibald Whidden son of Maxwell and Judith (Hendry) Whidden.
- 6. Jesse Boliva Mizell, Jr., born January 16, 1884; married Melda (Cline) Mizell after the death of his brother.

Jesse B. Mizell was sheriff of Manatee County in the mid 1870's. On November 9, 1876 Jesse purchased 40 acres of land at \$1.00 per acre from the State of Florida Internal Improvement Fund. This land was located in the $SE\frac{1}{4}$ of $SE\frac{1}{4}$ of section 21 in Township 37, Range 23, near Pine Level and west of Horse Creek. On May 4, 1877, Jesse B. and Frances M. Mizell of Pine Level sold this 40 acres to H. S. Seward of Pine Level for \$300.00.

The Mizell family later moved to the Caloosahatchee River valley area near present day Ia Belle. They owned lot #1 in section 19 in Township 42 south, Range 30 east which totaled about 45 acres. This land was located north of the Caloosahatchee River near Lake Flint and Ortona, in present day Glades County.

During a cattle dispute, Jesse B. Mizell was shot and killed on June 13, 1884 at Fort Thompson. He was buried at the Henry Ford place east of La Belle.

Frances Micheal (Albritton) Mizell married Andrew Jackson "Jack" McLenon in Monroe County on December 6, 1886. They had six children. Frances died February 13, 1915 and was buried in the Fort Ogden Cemetery.
