DIMMICK, dau. of Samuel & Mary Dimmick, b. at St. Lawrence County, NY; both of Nebraska City; md. in the 1st Presbyterian Church, by the Rev. H.M. Giltner.
40. Aug 3, 1861 (Jul 31), JULIAN METCALF of Nebraska City, b. at Charlestown, Sullivan County, NH, 1833 and came to Nebr. City, 1857; md, MISS JULIA B. KINNEY, eldest dau. of Hon. J.F. Kinney, Chief Justice of Utah and Hannah H. (Hall) Kinney. She was a niece of Chief Justice Augustus Hall, and came to Nebr. City in the Spring of 1853. Andreas, History of Nebraska, p. 1220-1225. Julian and Julia md. at St. Mary's Parish, by the rector, Rev. Eli Andams.

Daniel Heileg, b. in Virginia, at the residence of the bride's father by Rev. Isaac Chivington, Pastor of the Methodist Church.
47. May 31, 1862 (May 14), DR. J.C. CAMPBELL, b. near Lexington, KY, Dec 22, 1814 and settled at Nebraska City, Nov 1854; md. his second wife: MISS SARAH P. CHILDS of Deposit, NY.
48. May 31, 1862 (May 25), ROBERT T. GALE, md, MISS AMELIA WOOLEY, both of Otoe County, at the residence of the bride's father by Rev. John Miller Taggart, Baptist Minister, who settled in Nebraska Territory, 1856 at Fontenelle.
49. Jun 7, 1862 (May 31), DR. SYLVESTER DUNKIN, md. MISS M. AMANDA GREGG, both of Nebraska City, at Pleasant Ridge parsonage, by Rev. H.M. Giltner.
50. Jun 21, 1862 (Jun 19), WM. FULTON of Nebraska City, md. MISS N.L. SIMPSON of Westport, Missouri, at the residence of Nathan L. Simpson, by Rev. H.M. Giltner.
51. Jul 5, 1862 (Jul 2), W.L. PREY, md. MISS MARY E. MOORE, both of Nebraska City, by Rev. T.B. Lemon.
52. Sep 6, 1862, Petition for divorce, Otoe County: MARY REBECCA WHEELER, vs. HENRY M. WHEELER.
