Signed by James May Porter and witnessed by Charles Winfree, Richard Ligon, and Wm. May Porter. [35] Received this 3<sup>rd</sup> day of December 1789 of Robert Jones the sum of Thirty one pound . . . signed James May Porter. Signed by Saml. Ford Deputy and Exor. of Christo. Ford Decd. late Shf. Court held for Nottoway County the 7<sup>th</sup> January 1790, This Indenture was acknowledged by Samuel Ford the party thereto & to be Recorded.

This Indenture made this the fourth day of February 1790 between Robert Fitzgerald of the county of Nottoway of the one part and Francis Fitzgerald of the said County of the other part . . . for and in consideration of the sum of Three pounds . . . doth grant, bargain sell and confirm unto the said Francis Fitzgerald . . . a certain tract or parcel of land containing Two hundred and eighteen & an half acres. . . lying and being in the county of Nottoway on the north side of Little Nottoway River [39] and bounded as followeth, Beginning at a Butterwood on the head of Valls branch, thence north 60 East 173 poles to pointers, thence a new dividing line, South 18 1/2 West 430 poles to an ash on little Nottoway aforesaid, thence up the said river as it meanders to the mouth of Valls branch aforesaid, and thence up the said branch as it meanders to the first station . . . Signed by Robt. Fitzgerald. Court held for Nottoway County the 4<sup>th</sup> day of February 1790, This Indenture was acknowledged by Robert Fitzgerald and ordered to be recorded.

This Indenture made this eighteenth day of August one thousand seven hundred and eighty nine between Ambose (sic) Ellis and Cicely Ellis his wife of the County of Lunenburg of the one part and Littleberry Ellis of Nottoway County of the other part, . . . for and in consideration of the sum of Fifty one pound eight shillings and six pence farthing . . . [40]doth bargain sell alien enfeoff and confirm unto the said Littleberry Ellis one certain tract or parcel of land, lying and being in the County of Nottoway Containing one hundred and fifty three acres . . . lying as followeth, to wit, Beginning at Thomas Jeffress Senr. line on Nottoway river, thence along his line to a Corner, thence along said Jeffresses line to Littleberry Ellis line, thence along said Ellises line to the river, thence down the said river as it meanders to the beginning . . . signed by Ambrose Ellis and Cicely Ellis and witnessed by William Cain, George Barnes, James Barnes, and E.? Ellis . Memorandom that quit and peaceble possession of the within sold land was taken by the said Ambrose Ellis and delivered unothe said Littleberry Ellis . . . [41] Received of Littleberry Ellis the sum of Fifty

one pounds eight shillings & 6-- . . . signed Ambrose Ellis and witnessed by George Barnes, Wm. Cain and E.? Ellis. Court held for Nottoway County the 4<sup>th</sup> day of February 1790, This Indenture memorandom and receipt thereon endorsed was proved by the oaths of the Three of the Witnesses thereto and ordered to be recorded.
